THOUGHTS ON D-DAY 2020

THIS DAY used to be commemorated regularly on newspaper editorial pages: the day when Allied forces invaded Europe and began the long, bloody march to Germany. In time, the custom faded, but still the papers would receive letters to the editor every year complaining about the absence of a tribute on June 6, letters mostly from the dwindling number of people who remembered that day all too well.

Today, it's worth reviving the custom, if only because of the lesson it contains about leadership and its obligations — a lesson that seems to have been largely forgotten by many

of our leaders. In June 1944, Dwight D. Eisenhower, the supreme Allied commander, faced a harrowing choice about whether to proceed with the invasion of Normandy. The weather was terrible, the prospect of huge casualties all too real. But to delay any longer would be disastrous, Eisenhower believed. He made the decision to go ahead.

"During the somber lull between the decision and the invasion, Ike scribbled a quick note and stuffed it in his wallet, as was his custom before every major operation," <u>writes</u> Tim Rives, deputy director of the Eisenhower presidential library. Chances are you have read it before, but it's worth another look; it has special meaning this D-Day. Eisenhower intended it to be made public in the event the invasion was repelled. <u>It read simply</u>:

"Our landings in the Cherbourg-Havre area have failed to gain a satisfactory foothold and I have withdrawn the troops. My decision to attack at this time and place was based upon the best information available. The troops, the air and the Navy did all that Bravery and devotion to duty could do. If any blame or fault attaches to the attempt it is mine alone."

"Ike disdained pomposity in word and manner," writes Mr. Rives. "He disliked the 'slick talker' and the 'desk pounder.' The histrionic gesture or declamation just wasn't in him." But in the last sentence of a hastily written note 76 years ago, the future president said all that needed to be said about the essence of leadership and the locus of responsibility, in words that are not heard often today, and never from our president when fault or blame is to be assigned. (Ed note: this was written last year; thankfully President Biden doesn't blame others for his decisions.)



The St. Petersburg-based Democratic Congressman gave a speech shortly before noon [on May 4] in front of supporters in South St. Pete, where he lambasted Gov. Ron DeSantis and the GOP-controlled Florida Legislature.

"This is a governor who doesn't listen, doesn't care, and doesn't think about you- unless you can write a campaign check," he said. "He sees our state's wonderful diversity as a threat, not a strength we all celebrate."

The 64-year-old Crist (he'll be 65 in July) has already served as governor of Florida – when he

was a Republican (2007-2011), sandwiched between the Jeb Bush and Rick Scott eras. Crist narrowly lost to Scott when he ran as a Democrat in 2014.

The former Republican is running on a progressive agenda. He said in his speech that he supports legalizing recreational marijuana, raising the minimum wage to \$15 an hour and banning assault weapons.

And he said he would name a Chief Climate Change Officer to tackle what he calls the "existential threat" that a heating planet means to Florida's future.

Crist supporters say his brand of moderate politics can play well in such a time of tumult.

"This has been a really divisive few years, for Florida and for our country and it's really important that we get beyond this and focus on the issues for the people of Florida and I don't know anyone better than Charlie Crist whose been able to do that," said longtime Crist supporter Susan McGrath after his speech.

Crist is one of several Democrats who will enter the primary for 2022. Agriculture Commissioner Nikki Fried made it pretty clear after today's Cabinet meeting that she will soon be filing to run, saying as the top-elected Democrat in Florida, "it makes absolute sense for me to be running for governor," adding that such an an-

nouncement would not take place today.

The jockeying for who will succeed Crist in Florida's 13th Congressional District began did on Monday, when the GOP nominee in 2020, 31-year-old Air Force Veteran Anna Paulina Luna, became the first name Republican to enter the race.

When it comes to Democrats, the most frequently invoked names by politicos to get into the race is St. Petersburg-based state Rep. Ben Diamond and former Obama administration official Eric Lynn. St. Petersburg Mayor Rick Kriseman has declined to run for this seat.

in Pinellas County, Florida. First elected to St. Petersburg City Council 2013, Darden was re-elected in 2017 with over 72% of the vote. She is the current Chair of Forward Pinellas, the county's land use and transportation planning agency, and an executive member of the Board of Directors for Tampa Bay Water, the regional water supply utility.

Darden previously served as the president of the League of Women Voters of the St. Petersburg Area and as chair of the Pinellas Suncoast Transit Authority, as well as the Chair of City Council. Before being elected to City Council, Darden was the Florida Director of Healthy Gulf, an anti-pollution non-profit focused on protecting our coastal waters, a Senior Associate with Sierra Club Florida, and the Health Care Policy Director for Progress Florida, a non-profit dedicated to promoting progressive values throughout the state.

Councilmember Rice created the Wage Theft Prevention ordinance, was the driving force behind universal curbside recycling, and founded the council

and his family moved to Seminole Florida in 1988. He always held an interest in politics and Joined the PCDEC in 2004. quickly got immersed in the KERRY Campaign for president. He organized Meet and Greet meetings through the MoveOn organization and participated in various roles at the Pinellas Park Kerry field office. That year he attended the State Delegate Meeting and had the chance to meet with candidate Kerry.

He continued his involvement in the PCDEC as a precinct captain working on local campaigns. He soon realized that being involved with candidate campaigns was the thing he liked doing. In time he met Janet Long and maintained close a friendship with her which continues today. In 2012 President Obama visited the City of Seminole and Bob was a volunteer at the SPC Seminole campus site where Obama was to speak. He spent the night with many other volunteers erecting stands and stages in preparation for the President's visit. Later that day he had the opportunity to speak with Sen Bill Nelson and Charlie Crist.

In 2009 he accepted the opportunity to work in Patricia Plantamura's Seminole City Council campaign. Everyone worked on an aggressive campaign and she, against all odds, won her seat. She was the only Democrat out of an eight-member board.

He was asked to become the treasurer of Jack Killingsworth's SOE campaign effort in 2012 and worked with Jack on a second campaign a few years later.

In 2016 he was elected District 66 Chair. Prior to that he served as vice chair of district 51 (which later became D66). Dennis Port was the district chair and Bob

felt that he learned a lot of valuable lessons from him.

Currently Bob continues to enjoy being active in the LMPDC and playing an active role in Democratic campaigns. **

Abraham Lincoln issued the **Emancipation Proclamation** on January 1 1863. This news was not given to enslaved people in Texas until June 19 1865 because slave owners wanted to complete the harvest and feared if the enslaved people were informed of this they would stop working. Along with the fact that the Union Army was responsible for enforcing the Proclamation and until they occupied the territory Slave owners would not tell slaves they were free or would not release them until forced to do so.

Consequently, it became known as Juneteenth a combination of June and 19th. It was then that General Gor-

don Granger delivered the message in Galveston Texas that the war was finally over. Part of the message including the statement "This involves an absolute equality of rights and rights of property between former master and slaves". Enslaved black people now found a reason to celebrate.

Juneteenth is a way for African Americans to celebrate what our ancestors endured and reflect on the beginning of a journey to equality which is still not complete. It is an integral part of American history to be appreciated by all American Citizens as it portrays the struggle of a nation striving for perfection for all it citizens who have played a vital role in making The United States of America great.

Juneteenth is now an official federal holiday.



What you need to know

- President Biden signed a bill to establish Juneteenth as a federal holiday commemorating the end of slavery in the United States.
- The legislation gained momentum in the wake of the police killing of George
 Floyd last year —
 but Congress has made little progress on federal police reform. A bill named for Floyd remains stalled following Republican opposition.
- At the same time, multiple states have moved to ban teaching critical race theory in schools.

A Time for Change at the Florida Democratic Party

This is a very exciting time for the Florida Democratic Party! In May, the State Executive Committee voted by a two-thirds majority to approve a new voting structure to eliminate the weighted vote.

Under the new voting structure committee members (instead of votes) will be apportioned to the state's 67 counties. In addition, the FDP will become a national model for diversity and inclusion. County parties will now work with the FDP to assess the demographics of their Democratic voters and to create programs with specific goals to reach out to our historically derrepresented constituencies. Ultimately, this will help to make our governing bodies at the county and state levels more inclusive and representative of our Democratic voters.

Our state party's current voting structure was designed in the 1970s, when Florida had 8.5 million residents and 15 congressional districts. That structure allows multiple votes to be allocated to members depending on the county they represent. Memcated 1 to 3 votes; members from vote needed. Rules fundamental principle of 'one person, one vote." They gave the FDP until August 2020 to change the State Party's voting mechanism or face the possible removal of its DNC members. Sadly, the FDP leadership at the time did nothing. As a result, a challenge has been filed against the state's DNC members based on the fact they were elected using weighted votes and that issue is pending before the DNC's Credentials Committee.

The push to move away from the use of weighted votes was a prominent issue among candidates running for State Party Chair at the January 2021 organizational election. In his December 17, 2020, campaign email "One Party, One Future," Manny Diaz stated his commitment to working "to find a new vote structure that better reflects a more inclusive process on how we conduct our business." He also promised to expand opportunities to make sure "underrepresented communities inside and outside the party [will] have a seat at the table."

Following his election, State Chair Diaz appointed a Rules Committee and charged the members with the task of developing a plan to replace the current weighted vote structure and to bring the proposal to the state committee for a vote within his first 100 days.

Through a series of meetings, the FDP Rules Committee ultimately approved a proposal to replace the weighted vote system with a one vote per member system. The committee determined that a total of 400 members should be apportioned among the 67 counties an increase of 266 members over the 134 members already allocated based on each county having two members. Members will be allocated to the counties based on each county's Demo-

However, there is one more hurdle to cross before the new changes can go into effect.

cratic registration and election performance. Based on that, the 400 members are to be apportioned to the counties using the Method of Equal Proportions -- the same method the US Congress and the Democratic National Committee use to apportion their members. Based on the current calculations, Pinellas County will have 18 members.

Under the approved changes to the FDP Bylaws, work on the new diversity outreach and inclusion programs by the FDP and county parties should begin right away. This change will have an enormous effect on the composition of our state committee membership. Right now, there are seven Hispanics elected from the counties to serve on the state committee. Under this new program, we could have a goal to elect 82 Hispanic members. Currently, we have 36 African American members from the counties. Under the new changes, our goal could be to elect 108 members.

Moving away from a limit of two members per county opens opportunities for all our Democratic constituencies to have better representation on the state committee.

The election of the new members will take place in the normal election cycle -- during the Party's organization meetings following the presidential election. Waiting until December 2024 will give county parties time to revise their bylaws and institute new and expanded outreach programs. At the same time, it gives the state committee time to make fine-tuning adiustments to the Charter and Bylaws to address issues that might arise as implementation is underway.

However, there is one more hurdle to cross before the new changes can go into effect. During the virtual State Executive Committee meeting in May, the FDP used an online system for voting. Apparently, Ken Evans, the State Committeeman from Broward County cast his 59 votes against the change, but his votes failed to record in the system. According to the vendor, it appears to be a matter of user error because Mr. Evans had opened multiple voting tabs, contrary to repeated instructions by staff during the meet-Including Mr. Evans' weighted votes in the total will kill the amendment and keep the status quo. State Chair Diaz said he cannot change the announced vote but has invited Mr. Evans to file an appeal with the FDP's Judicial Council to have that body review the facts and determine the outcome -- including possibly holding re-vote by the State Executive Committee.

Thus, while 93 state committee members cast 695 votes (68.34%) in support of this longneeded change to the state committee's voting structure, and 46 members cast 322 votes (31.66%) against the change, this matter has yet to be finally

Today the reform proposal, authored by Rick Boylan and eloquently championed by Kyandra Darling, passed with 68.3% of the vote.

We will have three years to build a bigger and more diverse party capable of filling 18 state committee seats. Each new state committee member will have one vote.

With this good news, we must recommit to our efforts to be intentional in building the most diverse, inclusive and effective party in Florida. It won't be easy, few worthy endeavors are, but, as the old adage goes, we can do hard things!

Let's get started!

Lincoln's martyrdom enshrined his greatness in our collective memory. Less discussed is the epic tragedy caused by the loss of his singular wisdom, goodness, pragmatism and deft political hand at shaping the post-Civil War world. The years that followed the Civil War are key to understanding who we are as a nation and facing the great national myth that at long lasts demands a full reckoning. The American Civil War was the first industrialized war in history. It killed 2.5 percent of the population and if it was fought today, adjusted for population. It would have killed 7 million people. The war wasn't just inevitable; it was predestined by the presence of the evil of human slavery on American soil. The war was just, necessary, brutal, tragic and unfinished. The idea of a separate slave nation in the Northern Hemisphere was forever ended but the culture that held the ambition to create one was not defeated. With peace, a traumatized nation moved forward and tried to heal. It was this desire that fueled the great lie in our American story.

The great lie was that there was honor and virtue in the Southern cause and that the war was about things other than slavery. It was entirely about slavery. The eight times wounded, fighting professor from Maine who spoke seven languages, Joshua Lawrence Chamberlin, was given the honor of accepting the Confederate surrender. He called the Union Army to attention as the vanquished Confederate soldiers lay down their battle flags and went home. Honor was a very different societal concept in 1865. The South lost the war but the victors allowed the fiction to root that the evil cause could accommodate Honor and Virtue within it.

The Confederate Army went home, defeated, but carrying the racial malice of the Confederacy in their hearts. There were two racial massacres in 1866. One was in Memphis and the other in New Orleans. The Memphis massacre began when white cops and Confederate veterans attacked freed slaves and

Black Union Army veterans. The New Orleans massacre similarly was an attack by a white mob of Confederate soldiers against peaceful black citizens and Union Army veterans. These attacks were instrumental helping pass Civil Rights legislation in 1866, the 14th Amendment and the election of the selfstyled Radical Republicans who put the South under military occupation and sought to break the culture of the defeated slave nation. Reconstruction ended in 1877 with corrupt political horse trading.

Jim Crow followed and another 85 plus years of full on racial terror and injustice until the Jim Crow South fell. The truth is that the South needed another generation of occupation. The defeated South built their new Confederacy on the shattered dreams and hopes of freed slaves who saw slavery give way to a new tyranny. There are no virtues to celebrate in the life of Robert Lee of Virginia. He was a traitor and a cruel slave master. The Confederacy was an evil cause that blights us still. Whitewashed history weakens the nation. This

argument about the past is important because the main point is that the same people who are fighting to restrict liberty, freedom and dignity for people on the basis of skin color today are the same people who venerate an evil cause with nostalgic delusions about its nobility. Freedom means freedom for everyone. The Tulsa Massacre of 1921 and other white attacks should be used in gauging the intent behind the building of Confederate Memorials of that era. Most of the debates taking place around these monuments leave out the important context of their construction.

They weren't built as symbols of remembrance to the awful price of war. They were mostly built in the 1920's as symbols of white supremacy. They were markers of oppression and lighthouses in the night to remind Black Americans about their subjugation. The 100 plus years of racial terror that followed a war fought over slavery deserve a couple chapters in American History Class. We have nothing to fear by facing injustice. It is necessary and overdue. It will help us become what an embrace of our highest ideals tell us we can become. \P

Republicans gerrymander too

I completely agree with Eric Zorn "Why 'fair' maps aren't fair" (May 19). Until there is a nationwide plan to end gerrymandering that every state has to abide by at the same time, Illinois' Demo crats would be foolish to give up their advantage in drawing our new voting
